

# SEFCRI REGION FWC ENFORCEMENT OFFICERS

- DADE COUNTY-20 officers
- 18 of which have less than 5 years exp
- 4 inland officers, 16 marine officers
- Broward County-17 officers.
- 11 of which have less than 3 years exp.
- 10 marine, 3 inland, 2 park, 2 investigators.



- Palm Beach County-14 officers
- Martin County 8 officers
- Don't have break down for marine vs inland.
- For Economic reasons, officers that reach 5 years look for other financial opportunities which include other departments, promotional advancement.





#### ENFORCEMENT

#### GENERALLY SPEAKING

- Officers make 1 resource cases a month on average and of course better officers make more.
- Typical lobster mini season an aggressive officer will make about 4 cases.



### Coral Reef Protection Enforcement

- The only Criminal FAC rule dealing with coral:
- 68B-42.009 Prohibition on the Taking, Destruction, or Sale of Marine Corals Sea Fans, and Non-erect, Encrusting Octocorals; Exception.
- (1) Except as provided in subsection (2), no person shall take, attempt to take, or <u>otherwise destroy</u>, or sell, or attempt to sell, any sea fan of the species *Gorgonia flabellum* or of the species *Gorgonia ventalina*, or any hard or stony coral
- What does otherwise destroy actually mean??????
- Touching, hitting with your anchor, laying your catch bag on a coral head, turning a coral head over??????



# Why officers have a difficult time enforcing the coral statute

- Lack of knowledge with regard to the Coral Reef Protection Act and how they can enforce the law.
- Officers don't have the <u>ability</u> or support to snorkel on damaged spots or to watch divers.



### No Take Zones

- People ask the question all the time about enforcing NO TAKE ZONES and think it would be difficult to enforce.
- When asked, officers felt it would be extremely easy to enforce a no anchor no take area.
- No brainer: as long as the area is marked.
   The rule would be black or white.
