#### ~ Meeting Objectives ~

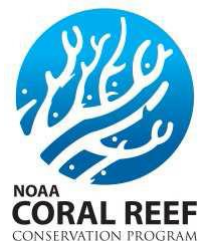
- Share new management actions proposed by group members, and add the actions that pass the quality check to the draft set of actions generated in September
